Indiana University Health Bloomington Hospital would like to amend its Byproduct Materials License, Number 13-10408-02, to delete Gregory Sutliff, M.D. and Philip Doering, M.D. from the list of Authorized Users. Both have discontinued practice at our facility.

Additionally, we request revision of the language of the authorizations of several of our Authorized Users as there has been confusion as to exactly what Authorized Users are authorized for. Up to amendment 58, our license permitted procedures licensed under 10 CFR 35.300, excluding iodine-131 for thyroid carcinoma. The Authorized Users David Lee, Sean Flynn, Bruce Monson, Mark Bisesi, and Chris McGary were approved for 35.300 (excluding iodine-131 for thyroid carcinoma) on amendment 58. Amendment 59 removed the exclusion for iodine-131 for thyroid carcinoma and the authorizations of those Authorized Users were altered to "35.300 (for iodine-131, oral administration of sodium iodine-131 in quantities less than or equal to 33 millicuries)". Subsequently added Authorized Users were also listed similarly even when only authorization for 35.392 was requested, leading to the appearance that the original Users were only approved for the use of I-131 up to 33 mCi, rather than all of 35.300, excluding I-131 in quantities greater than 33 mCi.

We request that Authorized Users David Lee, Sean Flynn, Bruce Monson, Mark Bisesi, and Chris McGary be listed as Authorized Users for materials licensed under "10 CFR 35.100, 35.200, and 35.300, except oral administration of greater than 33 mCi of sodium iodide-131". Additionally, we request that Authorized Users John Alexander, Jonathan Staser, and George Wolfer, Jr. be listed as Authorized Users for materials licensed under "10 CFR 35.100, 35.200, and the oral administration of sodium iodide I-131 in quantities less than or equal to 33 mCi". Finally, we request that Authorized User Nicholas Miller, M.D. be listed as an Authorized User of materials licensed under "10 CFR 35.100, 35.200 and the oral administration of sodium iodide I-131". Dr. Miller was added as an Authorized User in 2013 and the original request and supporting documentation was for authorizations 35.100, 35.200, 35.392 and 35.394. He was mistakenly added to the license as an Authorized User of only 35.100, 35.200 and 35.392 materials.
