You responded by letter received on October 23, 2015 (ML15302A390), and submitted an amendment request dated July 31, 2015 (ML15261A414).

After reviewing the information you provided in your response to the Notice of Violation, we have concluded that your completed and proposed actions appear to adequately address the regulatory noncompliance described in the Notice of Violation.
