Subject: Follow-up on Change of Ownership

Discussion: (10/15/15; 15:45) I left a phone message for Mr. Wise to call me concerning the Change of Control (MCN 586570) when my e-mail message was rejected. (16:37) Mr. Wise returned my phone call. He stated that he would be glad to help when I called him back. (10/16/15; 09:15) I spoke with Mr. Wise and told him I was following up on Craig Gordon's Change of Control Action. He stated that it was the intention of the licensee to allow the license to expire in June 2016. I stated that the NRC required that a request to terminate the license be in writing and to only be billed for half a year, the request should be received prior to March 31, 2016. Mr. Wise thought the most recent payment kept the license going through June 2016. I told him to contact Kelly Riner of NRC Fees Branch if he had any questions about what the licensee would owe next year. I asked Mr. Wise if the licensee had undergone a name change. Mr. Wise stated that the name would be System One Holdings, LLC and the address would be in Pennsylvania. I informed him this would necessitate the NRC to terminate the current license and issue another because the licenses are state specific. If the licensee would be terminating the license in the next three or four weeks, it would probably be better to wait till then and submit the termination request. Mr. Wise stated that he would get back in touch with me about the licensee's plans since the procedures for the other license had not been approved yet. When those are approved, they would be able to switch the operations to the other license and terminate this one. Mr. Wise also stated that the licensee only possessed material at temporary jobsites as the camera and source were shipped to the site directly by QSA and returned to them when the job was completed.
