Subject: RAI, AU Qualification

Discussion: I received Mr. Paradiso's letter stating his qualification, but it did not show experience with many of the isotopes used at the facility. He stated that he just needed to be added as the Radiation Safety Officer and not as an authorized user. I discussed what that meant and why we recommend that he be added as an authorized user for all materials on the license. I then discussed that he could get a 40 hour radiation safety course or work with the authorized users on the site to obtain experience with handling the other isotopes under the license. Mr. Paradiso said to just add him as the Radiation Safety Officer and not an authorized user until he obtains more training or experience.

Action Required: Add Mr. Paradiso as the Radiation Safety Officer.
