Under the Freedom of Information Act I request all non-publicly available agency records generated since September 18, 2012, pertaining to docket numbers 05000269, 05000270 or 05000287, and containing the word "Jocassee". Attached is a list of documents of which I am aware and that meet the directed search criteria. Please note that I do not consider this an all inclusive list in that it does not include documents whose access in ADAMS has been restricted from the general NRC population.

Under this FOIA request I am expecting all NRC documents pertaining to the flooding vulnerability that Lake Jocassee poses to the reactors at the Oconee nuclear station including records which have been restricted in their internal NRC access.

Please send all correspondence regarding this request to me electronically at (b) (6). Please provide the requested records electronically by making them publicly available through ADAMS. If there are any records or correspondence related to this request that cannot be provided electronically, please call me at (b) (6) and I will make arrangements to come by the FOIA office.

Since someone with the proper ADAMS access can find these records with a simple search using a few ADAMS fields, I do not believe that locating these records will take more than two hours of search time and therefore do not expect to accrue any search fees. Since these records exist in an electronic format and I am requesting electronic copies, I do not expect to incur any reproduction fees. Therefore, I am not filling out the paperwork for a fee waiver. If you determine that the requested records cannot be readily found in ADAMS, please let me know and I will provide my fee waiver justification at that point.
