Subject: Follow-up with on request for additional information

Discussion: Through a previous telephone conversation I explained to Ms. Almond that additional information was needed to approve the requested individuals as authorized users. I called to follow-up on the status of the information requested. Ms. Almond returned my call on 10/21 and stated that she faxed a copy of the appropriate Board certification for Dr. Panwar. She also stated that the other proposed user, Dr. Younas, will be going through the certification process in December and she will send the certificate then. She also asked if Dr. Younas would be able to work on cases under the supervision of another authorized user. I explained to Ms. Almond that we could process the current amendment request and add Dr. Panwar since he currently meets the qualifications to be added as an authorized user. I also explained that since Dr. Younas did not meet the training qualifications but would be going through the board certification process in December, the licensee could submit an amendment at a later date, once the board certification is received. I also informed her that Dr. Younas could work under the supervision of an authorized named on the license until that time. She stated that she understood and wished to withdraw the request to add Dr. Younas and would submit an amendment later at a later date.
