No, it is not confusing. NRC Regulations require that licensed material can only be transferred to another **authorized** recipient. Please review S.W. Cole's license. It does not authorize possession of Humboldt gauges, therefore according to NRC regulations you cannot transfer the gauge to them. S.W. Cole has requested to add Humboldt gauges to their license. You can transfer the gauge to them **after** their request is approved. S.W. Cole had also requested to add the 55 Leroy Road location to their license, but we cannot list one storage locations on two different licenses. That is why it is required that your license needed to be terminate before we can add this location on their license. Please check with Alan Brown and he should be able to explain this to you.
