I've reviewed your 2014 exempt distribution report that was received by Farrah Gaskins in NRC-Region I.

It appears that the report includes all of the required information.

We are collecting data in order to perform analysis of the general trends in exempt distribution. You have not provided the total quantities of products distributed nor the total quantities of radioactive material distributed, information that we are gathering. Although it is not required to provide this specific information, given the large volume of data submitted by Havells USA, I ask that you provide the following information:

- Total number of products distributed
- Total quantity of Kr-85 distributed in units of uCi or mCi.
