Dear Mr. Corte:

The Wyoming Department of Environmental Quality, Water Quality Division, Groundwater Pollution Control Section (GPC) reviewed the above referenced report. It is our pleasure to respond at this time. The report provides the surface and groundwater sampling and analytical results for the first half of 2015. The data was obtained during the May, 2015 sampling event at the Split Rock Mill Site.

The current report states that "the parameters meet the required limits in the license and are consistent with previous values and with values predicted by the site model". As noted in previous correspondence, monitoring well SWAB-1R continues to exhibit a general increase from September 2010 to the present in concentration levels for several constituents, pH, TDS, sulfate, and uranium. We agree that this is potentially related to migration of the contaminant plume.

Thank you for including the WDEQ on the mailing list and giving us the opportunity to review this data. Please be advised, Ms. Deborah Harris is no longer with the DEQ. We respectfully request that your mailing list be updated to reflect that change. In the event that you have comments or concerns please contact me at your earliest convenience.
