Re: Transfer of Control

Dear Sir or Madam.

Please expedite this request.

We respectfully request a review of a transfer of control for Cardio Consultants facility at 13303 Tesson Ferry Road, St. Louis, MO 63128 (See License We plan on assuming ownership on October 1, 2011 and request an expedited review so that we may maintain continuity of patient care.

Specifically, we are requesting transfer of control and ownership from Cardiology Consultants 13303 Tesson Ferry Road St Louis, MO 63128, to SSM Ambulatory Services, SSM Health-St. Louis, 1173 Corporate Lake Drive, St. Louis, MO 63132.

The six items of information required by NUREG 1556, Vol 9 follow below:

- 1. Complete description of the transaction:** The transaction is best described as a transfer of assets and management from Midwest Cardiovascular Consultants, Inc. to SSM Ambulatory Services, SSM Healthcare-St. Louis. The new name will be "SSM Esse Cardiology Consultants".
- 2. Describe any changes in personnel or duties:** There will be no changes in personnel for the Cardiac Imaging departments. All current employees are being retained and will continue in their current job scope. The Authorized User will remain the same. **There will be a change with the Radiation Safety Officer. A delegation of authority letter is enclosed.**
- 3. Describe any changes in the organization, locations, facilities, equipment or procedure:** There will be no changes in the organization (other than ownership), no changes in location, facility, equipment or procedures. This is an ownership and management change only.
- 4. Describe the status of the surveillance program (surveys, wipe tests, quality control):** A surveillance program was implemented to attain the NRC license initially and is in place currently. The same surveillance program will be continued with the ownership change.
- 5. Confirmation of records:** All records of the facility will be transferred to the transferee. These records include documentation of surveys of ambient radiation levels and fixed and/or removable contamination, including methods and sensitivity.
- 6. Confirmation of license commitments:** The transferee will abide by all constraints, conditions, requirements and commitments of the transfer.


