SUBJECT: ACKNOWLEDGEMENT OF REPLY TO ORDER IMPOSING CIVIL MONETARY PENALTY, BRADLEY D. BASTOW, D.O.

Dear Dr. Bastow:

On August 4, 2015, U.S. Nuclear Regulatory Commission (NRC) issued an Order to Bradley D. Bastow, D.O. (licensee), as a result of noncompliance with NRC regulations. The Order can be found in the NRC's Agencywide Documents Access and Management System (ADAMS) at Accession Number ML15181A222. Section V of the Order required the licensee to submit an answer to the Order, and you provided your answer in your Reply to the Order by letter dated September 14, 2015 (ML15266A184).

In your Reply to the Order, you committed to shutting down your facility at the above address by October 31, 2015, transferring all licensed material to an authorized licensee, and subsequently terminating your NRC License Number 21-32316-01 within 30 days following completion of shutdown activities. Further, you stated that you have entered into negotiations with a medical service company to provide cardiology services at its facility and under its license, and that you will not service as the Radiation Safety Officer. Finally, you requested that the NRC relax the monetary penalty based on Section IV of the Order upon demonstration by Bradley D. Bastow, D.O. of good cause.

The NRC staff considered information contained in your Reply to the Order and, in consultation with the Director, Office of Enforcement, granted the licensee an extension to notify the Commission of a successful completion of activities listed in its Reply to the Order by December 31, 2015. Furthermore, in accordance with Section IV of the Order, NRC will consider relaxation of the Order monetary penalty upon notification that Bradley D. Bastow, D.O. successfully completed all activities associated with: (1) shut down of the facility at the above address, (2) transfer of all licensed material to an authorized licensee, (3) termination of NRC License Number 21-32316-01, and (4) written notification to the Commission by December 31, 2015. Should the specifics of the above actions change, please notify us of the changes as the information becomes available. We request that these
