On October 22, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your Catawba Nuclear Station, Units 1 and 2. The NRC inspectors discussed the results of this inspection with you, and other members of your staff. The inspectors documented the results in the enclosed inspection report (IR).

No NRC-identified or self-revealing findings were identified during this inspection.
