Background

- 10 CFR Part 71 final rulemaking was issued June 12, 2015
- Effective date was July 13, 2015
- Update DOT and NRC regulations to harmonize with IAEA transportation requirements
- Part 71 QAP administrative procedures changes a subset of the overall rulemaking

Part 71 Changes

Applicable to Part 71 QAP approval holders

§ 71.38 Renewal of a certificate of compliance

- The title was revised to remove reference to QAP approvals
- Paragraphs (a), (b), and (c) were revised to remove reference to QAP approvals

Part 71 Changes

- There are no longer expiration dates for QAP approvals
- NRC Form 311 for QAP Approvals was revised to remove the expiration date block
- New Form 311s were mailed to all current QAP approval holders in August and September 2015

Part 71 Changes

§ 71.101 Quality assurance requirements

- Only editorial changes to remove references to “licensee” where not needed

§ 71.106 Changes to a quality assurance program

- New section added to establish requirements that will apply to changes to quality assurance programs

Part 71 Changes

§ 71.106 (a)

- Must submit to the NRC any changes determined to reduce commitments for prior review and approval

§ 71.106 (b)

- Allows QAP approval holders to make changes to previously approved programs without prior review and approval if the change is determined not to reduce commitments

Part 71 Changes

§ 71.106 (b) (cont.)

- Changes made that do not reduce commitments must be submitted to the NRC every 24 months
 - If no changes were made during the reporting period, the submittal is still required and would indicate no changes were made
- The 24 month reporting period starts on the date your revised Form 311 QAP approval was signed

Part 71 Changes

§ 71.106 (b) (cont.)

- Part 50 licensees may combine their Part 50 and Part 71 24 month QAP submittals on their current schedule
 - Add a reference to 71.106 and distribution per 71.1(a)

§ 71.106 (c)

- Shall maintain records of QAP changes

Part 71 Changes

§ 71.135 Quality assurance records

- Section revised to include those QA records that apply to changes made to previously approved QAPs
- Specifically, the second sentence of this section was revised to indicate the records must include changes to the QAP as required by the new § 71.106

Part 71 Guidance

- Reg Guide 7.10 was revised in June 2015 to include guidance on implementation of the new 71.106
 - Consider the need for working-level documents (procedures) for implementing changes to QAPs and performing required submittals
 - Changes to records documents should also be considered
