Thank you for taking the time to speak with me today. I have added some information to my questions and comments and included a couple more questions for Nuclear Regulatory Commissioner Chairman, Stephen Burns to answer and reply to.

Hello Mr. Comley;

Please confirm these are the questions you are directing to the Chairman's office.

When was a copy of the NRC's May 2015 reply sent to Mass. Rep. Hill?

What was the NRC's involvement in the MEMA June 1, 2015, session at Rowley? Did the NRC contact MEMA first. If so was it by letter or was it a verbal.

When will the NRC hold a meeting with first responders within 10 miles of Seabrook?

Has the Chairman been provided with a copy of my July 4, 2014 with the enclosures I referred to in my letter to the NRC in King of Prussia? If so has the Chairman reviewed the letter and enclosures? If not will Chairman Burns please review them before he replies to these questions? . .

What avenues does the NRC have to take action against Seabrook if the plant cannot meet emergency preparedness requirements? If first responders testify in their judgment they cannot evacuate citizens safely and timely within and outside the 10 mile radius of Seabrook Nuclear Plant, will the NRC revoke their license to operate?

I also am requesting that Chairman Stephen Burns respond to the fact there is a GAG order presently on the MA State Police and the New Hampshire National Guard that these first responders "are not to comment or make any political statements of any kind whether the Seabrook Evacuation plans could be implemented safely." Attached is recent guest column I wrote and was printed in MA, NH and beyond newspapers.

In my opinion these GAG orders on first responders make them expendable and places them in the same category as special needs citizens. Is Chairman Burns aware this is the very issue that got me involved into investigating the Nuclear Industries and their so called watchdog, the Nuclear Regulatory Commission?

How familiar is Chairman Burns with the legal history between the NRC and Mr. Comley? Attached Boston Globe Article about the Summary Judgment decision made by Judge Platt for the District of Columbia that Former NRC Executive Director, Victor Stello, NRC Chairman Lando Zech and NRC Law Judge, Ivan Smith were found guilty of violated my Constitutional rights as a American Citizen. Would like you legal staff to provide Chairman Burns with the complete case. I would like Chairman Burns reaction to these sacred rights the previous NRC highest officials tried to take from me.

How familiar is Chairman Burns with the Office of Inspector General reports conducted by the first and former NRC IG, David Williams completed?. These investigation were and are related to Seabrook construction and operation as well as other Nuclear Plants across the United States. I ask that Chairman Burns retain a copy of these reports and review them. In my opinion these NRC IG investigation are some of the most revealing investigations of the NRC failure to protect the safety of the American people.

It should be noted by Chairman Stephen Burns that the following NRC IG investigation Audits stated, "Review was prompted by allegations from We The People..":

1. Falsification of Welds Scandal at Seabrook Station involving James Padavano who I understand was TOLD to falsify the welds and only spent 6 months in Jail for it. More of the falsification of welds happened after Padavano but was never fully investigated. I spelled this out more fully in my Letter of July 4, 2014 to the NRC in King of Prussia.
2. NRC IG report of NRC improper disclosure of alleged identities by the NRC's office of Investigation to the Tennessee Valley Authority.
3. NRC IG investigative report regarding review of NRC's process for regulation Counterfeit and Substandard Parts used in U.S. Nuclear Power Plants.
4. NRC's IG report of NRC's compliance with notice of enforcement discretion policy and procedures.
5. NRC IG's event inquiry of NRC failure to adequately regulate Millstone Unit 1.

Why is it appropriate for Seabrook to have an unmanned security location at the entrance to the site? Why is that the NRC has not at least recommend that the so-called Security Booth either be torn down or manned. Attached is a guest column that was published in most MA, NH and was published in 35 counties and 21 languages by EPOCH TIMES a world newspaper .

Lastly, I want Chairman Stephen Burns to know that NRC IG, Mr. Hubert Bell has not contacted me ever since he was notified (will send a copy of that notice) January 23, 2015 by the lawyers in NRC King of Prussia that I have confessed to the tape-recording the NRC through the Department of Justice was hoping to acquire during a 6 years battle in MA Federal Court.

In addition, Mr. Bell has not bothered to contact me or respond to any of the safety concerns I mentioned in my letter of July 4, 2014 with enclosures which the Authorities in NRC King of Prussia sent him and obviously thought he should be made aware of.
