Data Package for the Strata Energy, Inc. Ross ISR facility, Crook County,

Wyoming.

#### BACKGROUND:

By letter dated July 17, 2015 (Agencywide Documents Access and Management System (ADAMS) Accession Number ML15209A703), Strata Energy, Inc. (Strata) submitted to the U.S. Nuclear Regulatory Commission (NRC) its Mine Unit 1 (MU1) Wellfield Data Package for the Ross in situ recovery facility located in Crook County, Wyoming. The package was submitted for NRC staff's review and verification pursuant to license SUA-1601, Condition 10.13.

By letter dated September 8, 2015 (ML15243A422), Staff notified Strata of two issues that were critical for the timely verification of the MU1 Wellfield Data Package. The issues were: (1) abandonment of historic drill holes pursuant to paragraph B of License Condition 10.12; and (2) incomplete characterization of the groundwater-flow paths pursuant to License Condition 10.13.

NRC staff requested this public meeting to discuss issues identified during its review. The public notice and preliminary agenda for this meeting are attached (Enclosure 1).

#### **DISCUSSION:**

NRC staff read the opening statement for a Category 1 public meeting. A list of attendees are attached (Enclosure 2).

The abandonment of drill holes was first discussed. Strata stated it did not agree with Staff's interpretation of this issue; however, to resolve it, Strata instructed its consultant to provide an update of the proposed finding/work. Strata's consultant provided the following:

Flow downgradient today is southward due to the pumping at the industrial wells. The southerly downgradient area from MU1 to the wells is approximately 750 to 950 feet wide and includes approximately 130 historic drill holes that extend to the DM unit. Without the industrial wells in operation, the downgradient flow would be to the northwest. The consultant reported that only a few historic drill holes are located in the northwesterly downgradient direction.

Strata reported that the abandonment will be completed within 3 weeks. Staff indicated it would expect a report on the abandoned drill holes prior to verification.

The issue of groundwater-flow paths, specifically the high-than-expected potentiomentric heads at several perimeter wells located along the southern boundary of MU1, was addressed by Strata's consultant. Strata's consultant provided the following:

An aquifer test was performed in the SM unit, specifically pumping at SM-10 with measurement of water levels at seven perimeter monitoring wells, six monitoring wells in the SM unit and one ore zone baseline well (OZ-22). The duration of the aquifer test was 24 hours. All SM wells exhibited drawdown during the test, only two perimeter wells, PM-19 and PM-12, exhibited drawdown, 1.4 feet and less than 0.1 feet of drawdown, respectively, the ore zone baseline did not exhibit drawdown.

Staff asked that in the report of the findings, Strata address the impacts on the future excursion monitoring at the perimeter wells that exhibit drawdown during the aquifer test.

There were no questions from the public or action items.

The meeting was adjourned at 10:30 a.m.
