This is in response to your 2016-0030 FOIA requesting contracts, MOU and MOA from DOE date range January 1, 2010, to the present. Under the NRC's FOIA regulations, at 10 CFR 9.40(e), unless a requester agrees to pay the fees estimated to be due, the NRC may not begin to process the request. Because these documents exceed the 100-page threshold at which you would be responsible for duplication fees and search criteria, you have clearly stated that you do not agree to a fee payment, your request is not considered "perfected" under the statute. Accordingly, we cannot process this request. It is incumbent upon you, as the requester, to fashion a request that asks for records within the 100-page threshold for which no duplication or search fees would be owed if you are unwilling to pay fees. *Your fee waiver is denied because you failed to provide justification for a fee waiver.*
