## General Comment

I object to the proposed 100 mSv per year of radiation exposure from nuclear reactors and other nuclear facilities. If you know your work at all then you know that this guarantees cancer for everyone in America. Who will pay for it? Who will take care of everyone? This makes you traitors of the worst kind.

According to the new Richardson et. al. government (taxpayer) funded study of US-UK and French nuclear workers, which was published in the British Medical Journal this October, 10 years of 100 mSv per year would lead to approximately 100 extra cancers per 100 people. Yes, 100% excess cancer rate! This is above and beyond current cancer rates.
