Update to Technical Requirements Manual and Technical Specification Bases

This letter provides the Northern States Power Company, a Minnesota corporation (NSPM), d/b/a Xcel Energy, updates to the Technical Requirements Manual (TRM) and Technical Specification (TS) Bases for the Monticello Nuclear Generating Plant (MNGP). The TRM is being provided in accordance with 10 CFR 50.71(e). The TS Bases are being provided in accordance with TS 5.5.9, "Technical Specifications (TS) Bases Control Program," on a frequency consistent with 10 CFR 50.71(e).

The TRM and TS Bases are being provided on the enclosed compact disc (CD). The CD provides the current copy of the entire MNGP TRM, Revision 17, and the current copy of the entire MNGP TS Bases, Revision 39. The previous update included MNGP TRM, Revision 13 and MNGP TS Bases, Revision 29.
