



10 CFR 20.1101(c) requires the licensee shall periodically (at least annually) review the radiation protection program content and implementation. Contrary to this requirement, the licensee had not reviewed the program since the last NRC inspection on October 20, 2010.

The licensee will complete a documented review of the radiation protection program content and implementation by December 15, 2015. To prevent recurrence, the licensee stated that future program reviews would be scheduled at least annually in a work tracking system to assure completion as required.

Statement of Corrective Actions

I hereby state that, within 30 days, the actions described by me to the Inspector will be taken to correct the violations identified. This statement of corrective actions is made in accordance with the requirements of 10 CFR 2.201 (corrective steps already taken, corrective steps which will be taken, date when full compliance will be achieved).
