Dear Mr. Mitchell:

The U.S. Nuclear Regulatory Commission (NRC) staff is preparing an advanced final safety evaluation (AFSE) for each chapter of the North Anna 3 Combined License Application submitted by Dominion Virginia Power (Dominion) by letter dated November 27, 2007.

The staff’s AFSE for Chapter 20, “Requirements Resulting from Fukushima Near-Term Task Force Recommendations,” is being provided to the Advisory Committee on Reactor Safeguards (ACRS) subcommittee to support review by the ACRS subcommittee.

The enclosed AFSE is being provided only to Dominion for review of proprietary information pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) 2.390 “Public Inspections, Exemptions, Requests for Withholding.” The staff concludes that the enclosed AFSE does not contain any information for which exemption from public disclosure has been sought or approved or any factual errors. However, the NRC will withhold the enclosed AFSE from public disclosure for ten business days from the date of this letter to allow you the opportunity to verify the staff’s conclusion that the AFSE contains no such exempt information or any factual errors. If within that ten day period, you do not request that all or portions of the AFSE be withheld from public disclosure, the enclosure will be made available for public inspection through the NRC Public Document Room and the Publicly Available Records component of NRC’s Agencywide Documents Access and Management System and placed on the NRC’s public web page for this application.
