To Whom It May Concern,

The purpose of this letter is to notify the NRC of a pending change of ownership for Johnson Memorial Hospital (Lic. No. 06-16624-01) located at 201 Chestnut Hill Road, Stafford Springs, CT 06076. Trinity Health – New England, Inc., (f/k/a Saint Francis Care, Inc.) has formed four, wholly-owned subsidiary companies, which will acquire the assets of Johnson Memorial Hospital and its affiliates out of bankruptcy. The assets of Johnson Memorial Hospital, Inc. (including all licenses and permits) will be acquired by JMH Acquisition Corporation. This acquisition is scheduled for December 31, 2015.


Trinity Health New England confirms the following:

- No changes in personnel or duties related to the radiation safety program will occur as part of this transition.
- No changes in location, facilities, equipment, or procedures relating to the radiation safety program will occur as part of this transition
- All records concerning the safe and effective decommissioning of the facility will be transferred to Trinity Health New England.
- Trinity Health New England will abide by all constraints, conditions, requirements, and commitments of the transferor made to the NRC.

Johnson Memorial Hospital and Trinity Health New England agree to abide by the above commitments as part of this change of control.

Description of Trinity Health – New England, Inc.

Trinity Health – New England, Inc. (the “Corporation”), is a Connecticut non-stock corporation formerly known as Saint Francis, *Care*, Inc. It is exempt from federal income taxation as an organization described under Section 501(c)(3) of the Internal Revenue Code. The sole member of the Corporation is Trinity Health Corporation (“Trinity”), an Indiana nonprofit corporation, or its successors or assigns. Trinity Health Corporation has the power to appoint and remove all of the Corporation’s Board of Directors and its President and Chief Executive Officer.
