Please see the below responses to the questions in your email dated December 9th, 2015 regarding our transfer of control application for license 10-23990-01E. If there is any additional information needed regarding these topics, please do not hesitate to let us know.

1. The NRC licensee (or the transferor) was the subject of an indirect change of control by the transfer of ownership of the parent of the transferor. The former owners of the parent of the transferor will not continue in any related business. The transferor will remain in non-licensed business without the license until a new license is obtained or the licensed is transferred.
2. The condition of the facility is excellent and remains unchanged since the initial license issuance. There is no contamination present.
3. No decontamination plans exist for the facility and are not required, nor are financial assurance arrangements per 10 CFR 30.35.
4. The transferee agrees to abide by all constraints, license conditions, requirements, representations and commitments identified in and attributed to the existing license without limitation. This agreement includes assuming responsibility for all open inspection items and enforcement actions, of which there are none, as well as decontamination activities and decommissioning of the site, which is not required and completing corrective actions for open inspection items and enforcement actions, again of which there are none.


