to the "flooding vulnerability that Lake Jocassee poses to the reactors at Oconee") or exempt from disclosure, are already, or will be made, available in public ADAMS, albeit under different ML#s than the ones cited in the listing attached to your request. Note also that one of the records included on the listing, ML13045A371, had been incorrectly indexed under one of the Oconee docket numbers; as its name implies, it pertains to the Vogtle nuclear power plant. The error has now been corrected in ADAMS. The record has been treated as non-responsive to your request. Note also that two of the four restricted records that were identified by ADAMS support personnel by searching on the parameters we agreed upon, have also been treated as non-responsive to your request as they are Operator Licenses that do not pertain to the flooding vulnerability that Lake Jocassee poses to the Oconee reactors.

And, finally, please note that, with respect to the three letters you authored that are included in this response, because you asked that we make the records publicly available in ADAMS (and not just provide them to you), we have redacted your home address and cell phone number (or considered the version of the letter already publicly available in ADAMS as responsive, consistent with NRC's practice regarding Personally Identifiable Information (PII)).
