We respectfully ask this request completed expeditiously. David Englehart, MS, present Radiation Safety Officer, has resigned his position as of December 31,2015.

Wally Fuhrman has been appointed Radiation Safety Officer for SSM Cardinal Glennon Children's Hospital and is responsible for ensuring the safe use of radiation. He is presently RSO for License number 24-15159-01. His responsibility is managing the radiation protection program; identifying radiation protection problems; initiating, recommending, or providing corrective actions; verifying implementation of corrective actions; stopping unsafe activities; and ensuring compliance with regulations. Mr Fuhrman is hereby delegated the authority necessary to meet those responsibilities, including prohibiting the use of byproduct material by employees who do not meet the necessary requirements and shutting down operations where justified by radiation safety. He is required to notify management if staff do not cooperate and do not address radiation safety issues. In addition, he is free to raise issues with the Nuclear Regulatory Commission at any time. It is estimated that Mr Fuhrman will spend an additional eight hours per week conducting radiation protection activities.

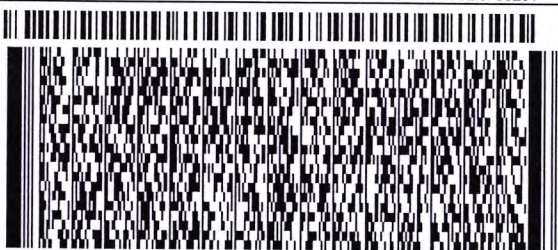

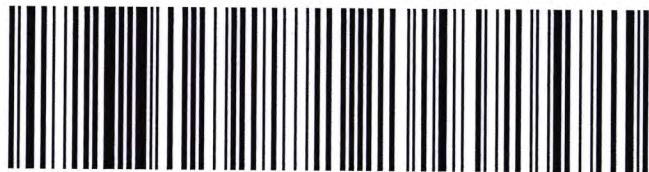
