On November 19, 2015, the U.S. Nuclear Regulatory Commission (NRC) cited TEAM Services, Inc. for failure to comply with the portable gauge security requirement in 10 CFR 30.34(i). The Notice of Violation, enclosed with Inspection Report 030-37929/2015-001 (ML15293A173), required you to respond in writing within 30 days. You responded by letter received on December 1, 2015 (ML15351A482).

After reviewing the information you provided in your response to the Notice of Violation, we have concluded that your completed and proposed corrective actions appear to adequately address the regulatory noncompliance described in the Notice of Violation. We will review your implementation of these corrective actions during a future inspection to determine whether full compliance has been restored and whether compliance will be maintained.
