
### Radiation Safety Officer Delegation of Authority

The management of Beaumont Cardiovascular Specialists appoints Cheryl Culver Schultz, M.S. as the Radiation Safety Officer, who agrees to be responsible for implementing the radiation protection program and conditions specified in our NRC License (21-20324-01). The management of Beaumont Cardiovascular Specialists grants the Radiation Safety Officer the authority, organizational freedom, and management prerogative to:

- 1) Identify radiation safety problems;
- 2) Initiate, recommend, or provide corrective actions; and
- 3) Verify implementation of corrective actions.

The Radiation Safety Officer has the authority to immediately stop any operations involving the use of radioactive material in which health and safety may be compromised or may result in non-compliance with NRC requirements.


