
This letter is a follow-up to ATC's Amendment Request for License No. 13-17732-01, dated November 20, 2015, ("Amendment Request") and subsequent email communications regarding the information presented in the Amendment Request.

As per the Amendment Request, ATC requested a name change from ATC Group Services Inc. dba Cardno ATC to ATC Group Services LLC. Under the laws of the State of Delaware, ATC was converted from a corporation to a limited liability company. This conversion has been completed in Indiana, as well. ATC Group Services is still the same legal entity, but it now exists as a limited liability company instead of a corporation. The federal tax ID number remains the same.

Furthermore, ATC Group Services is still wholly-owned by ATC Group Holdings. As such, there is no change in ownership of ATC Group Services. There has further been no change in the control or ownership of the license, as there have been no changes in the organization, location, facilities, equipment, or procedures with respect to licensed activities. Any change that ATC has undergone does not involve change in the corporate structure responsible for management oversight, control or radiological safety of the licensed materials. The surveillance program in place at ATC Group Services LLC, 7988 Centerpoint Drive, Suite 100, Indianapolis, IN 46256-3345 related to radiation surveys and source leak test requirements will continue to remain in effect.
