During the period 01/01/15 through 12/01/15, UTC Fire & Security Americas Corporation, Inc. in Pittsfield, Maine transferred a total of 4,605 ionization type smoke detectors under the conditions set forth on the referenced license. An itemized list of catalog number, quantity per year and source activity in microcuries is attached.

All 4,605 units consisted of the 235 Series chamber listed on the referenced license.
