Reference: Letter from J. P. Gebbie, Indiana Michigan Power, to U. S. Nuclear Regulatory Commission Document Control Desk, "Donald C. Cook Nuclear Plant Units 1 and 2, License Amendment Request to Adopt TSTF-425-A, Revision 3, 'Relocate Surveillance Frequencies to Licensee Control – Risk Informed Technical Specification Task Force (RITSTF) Initiative 5B'," dated November 19, 2015.

In the above referenced letter, Indiana Michigan Power Company, the licensee for Donald C.
