**Unified Agenda of Federal Regulatory and Deregulatory Actions: Semiannual Regulatory Agenda: Chapter 1 of Title 10 of the Code of Federal Regulations (NRC-2015-0222)**

On December 15, 2015, the NRC published its Semiannual Regulatory Agenda (the Agenda) in the *Federal Register* ([80 FR 78108](#)) in accordance with Public Law 96-354, "The Regulatory Flexibility Act," and Executive Order 12866, "Regulatory Planning and Review." The Agenda is a compilation of all rules on which the NRC has recently completed action, has proposed, or is considering action. This issuance of the NRC's Agenda contains 34 active and 23 long-term rulemaking activities: three are Economically Significant; 10 represent Other Significant agency priorities; 50 are Substantive, Nonsignificant rulemaking activities; and two are Administrative rulemaking activities. In addition, four rulemaking activities impact small entities. The public comment period on the Agenda closes on January 14, 2016.

**Draft Guidance Documents for Subsequent License Renewal Published for Public Comment**

On December 15 and 16, 2015, the staff published for public comment draft guidance documents for subsequent license renewal: NUREG-2191, "Generic Aging Lessons Learned for Subsequent License Renewal (GALL-SLR) Report," and NUREG-2192, "Standard Review Plan for Review of Subsequent License Renewal Applications for Nuclear Power Plants" (SRP-SLR). These draft documents describe methods acceptable to the staff for managing aging for reactor operation from 60 to 80 years, as well as techniques to be used by the staff in evaluating applications for subsequent license renewal. The NRC plans to hold public meetings during the public comment period, which ends February 29, 2016, to foster more informed comments and discussion on the draft guidance documents.
