SUBJECT: NOTICE OF CONSIDERATION OF APPROVAL FOR THE INDIRECT TRANSFER OF CONTROL (CHANGE OF CONTROL) OF THE U.S NUCLEAR REGULATORY COMMISSION MATERIALS LICENSE NO. SUA-1580, CROWNPOINT URANIUM PROJECT, MCKINLEY COUNTY, NEW MEXICO, FROM HYDRO RESOURCES, INC., TO LARAMIDE RESOURCES LTD., OPPORTUNITY TO PROVIDE COMMENTS AND TO REQUEST A HEARING (TAC NO. L00799)

Dear Governor Montoya:

The U.S. Nuclear Regulatory Commission (NRC) received and is considering approval of an application for indirect transfer of control filed by Uranium Resources, Inc. (URI), on behalf of its wholly-owned subsidiary Hydro Resources, Inc. (HRI), to Laramide Resources Ltd. (Laramide), dated November 27, 2015. The application seeks NRC approval of the indirect transfer (change of control) of NRC Materials License SUA-1580 for the Crownpoint Uranium [*In Situ* Recovery (ISR)]¹ Project from HRI to Laramide. The NRC is notifying you of this action as you may have an interest due to the proximity of the project to Tribal lands.

HRI possess the Crownpoint Uranium Project uranium milling license SUA-1580. The Crownpoint Uranium Project is located in McKinley County, NM and contains four locations, Crownpoint, Unit 1, Churchrock Section 8, and Churchrock Section 17. The Crownpoint Uranium Project has not been constructed and has not operated.

On November 9, 2015, URI entered into a Letter of Intent with Laramide for the sale of NRC licensee HRI to Laramide (proposed transaction). The parties to the proposed transaction have requested that the NRC consent to the proposed indirect transfer of control as being in accordance with Section 184 of the Atomic Energy Act of 1954, as amended, and 10 CFR § 40.46. As a result of the proposed transaction, HRI has also requested an administrative amendment to the License to reflect HRI's new address: 62329 North Star Drive, Montrose, CO 81403.
