On December 10, 2015, the U.S. Nuclear Regulatory Commission (NRC) completed a security baseline inspection at your H. B. Robinson Steam Electric Plant, Unit 2. The inspection covered one or more of the key attributes of the security cornerstone of the NRC's Reactor Oversight Process. Portions of the inspection associated with Access Authorization, Protection of Safeguards Information, and Fitness-for-Duty were completed at the Duke Corporate Office on December 4, 2015. The enclosed inspection report (IR) documents the inspection results that were discussed on December 10, 2015, with Mr. Isgett and other members of your staff. The enclosed IR also documents the inspection results that were discussed on September 17, 2015, with Mr. R. Hightower and members of your staff.

No NRC-identified or self-revealing findings were identified during this inspection.
