

Key Public Interactions

Throughout the U.S. Nuclear Regulatory Commission's (NRC) effort to revise the acceptance criteria for nuclear power reactor emergency core cooling systems (ECCS) in Title 10 of the *Code of Federal Regulations* (10 CFR) Part 50.46, the staff has interacted frequently with public stakeholders to enhance the transparency of and public involvement in the ongoing activities.
