Dear Director:

It has been brought to my attention that generally licensed HP/Agilent detector serial# K4275 is still listed with the NRC as a source in our possession at NOAA/ESRL in Boulder, CO. This is incorrect. The detector was sent back to HP/Agilent (see attached) in June of 1998. It appears that it was an oversight of my predecessor RSO to notify the NRC, as required, within 30 days of return to HP/Agilent.

As a general license material, this detector was returned to the manufacturer under their license authority.

Please accept this letter as notification that HP/Agilent detector Model# G153360550 and Serial# K4275 was returned to the manufacturer on June 19th, 1998 in accordance with 10 CFR 31.5(c)(8)(ii).
