AMENDMENT TO INDEMNITY AGREEMENT NO. B-49  
AMENDMENT NO. 13

Effective April 15, 2016, Indemnity Agreement No. B-49, between Entergy Nuclear Vermont Yankee, LLC, Entergy Nuclear Operations, Inc., and the U.S. Nuclear Regulatory Commission, dated November 30, 1970, as amended, is hereby further amended as follows:

Article VIII of the indemnity agreement is deleted in its entirety wherever it appears in the agreement, and is substituted therein by the requirements of the exemption permitting a reduction in primary financial protection from \$375,000,000 to \$100,000,000, and withdrawal from participation in the secondary layer of financial protection.

Item 2a of the Attachment to the indemnity agreement is deleted in its entirety and the following substituted therefor:

Item 2 – Amount of financial protection

a. \$100,000,000 (From 12:01 a.m., April 15, 2016)
