Dear Mr. Ballard:

On July 7, 2015, the U.S. Nuclear Regulatory Commission (NRC) amended the radioactive materials license for the Bear Creek Uranium Company to include the name of the new project manager for the Bear Creek project (Agencywide Documents Access and Management System (ADAMS) Accession Number ML15168A243). A review of the license revealed that the license and docket number on pages 4 through 7 are incorrect. Enclosed is the corrected license for the Bear Creek facility.

An environmental assessment was not performed for this action as it is categorically excluded under 10 CFR 51.22 (c)(10)(v).
