Dear Mr. Rusche:

Pursuant to 10 CFR 50, Section 50.90, an amendment to Section 6.1 of the Oconee Nuclear Station Technical Specifications, Appendix A to Facility Operating Licenses DPR-38, -47, and -55 is proposed. Specifically, please find attached a proposed change to Figure 6.1-1 entitled "Station Organization Chart". This chart is referenced by Technical Specification 6.1.1.3 and depicts the station organization for Operations, Technical Services, and Maintenance. Proposed changes to the station organization as reflected by this chart are as follows:

The "Instrument and Control" section has been redesignated as the "Instrument and Electrical" section, and the "Maintenance" section has been redesignated as the "Mechanical Maintenance" section.

By redistributing personnel assignments, the Maintenance Organization is more effectively divided into two more distinct branches, with one branch responsible for only mechanical maintenance and the other only for electrically-related maintenance. This reorganization provides a more logical assignment of maintenance personnel and thereby will afford a more efficient overall Maintenance Organization.

We request that approval of this Technical Specification change be granted as expeditiously as possible.


