Dear Administrative Judges:

On December 24, 2015, the Staff submitted a letter to the Board stating that, contingent upon the Staff's acceptance of Crow Butte's health physics RAI responses in March 2016, the Staff expects to issue its draft Environmental Assessment (EA) by August 31, 2016, and the final EA and Safety Evaluation Report by November 30, 2016.

On January 13, 2016, the Board issued a Memorandum and Order scheduling a prehearing conference to discuss, in part, the Staff's plans for the public availability of the draft EA. In that Order, the Board noted that the Staff's plan for issuance of the draft EA in the Crow Butte Marsland proceeding appeared to be inconsistent with its plan for issuance of a draft EA for public comment in the pending Crow Butte North Trend Expansion Area proceeding.¹

The Staff wishes to clarify its letter of December 24, 2015, by affirming that the publication of the draft EA for the Marsland Expansion Area will be for public comment. This is consistent with the Staff's current approach in the environmental review of the Crow Butte North Trend Expansion Area application.
