DTE requested renewal of the Fermi 2 operating license (operating license NPF-43) for a period of 20 years beyond the current expiration at midnight on March 20, 2025.

The license renewal staff and technical branches have completed their review of the applicant's LRA and have issued the "Safety Evaluation Report with Open Items Related to the License Renewal of Fermi 2" (ADAMS Accession No. ML16027A270). The Fermi 2 LRA is currently scheduled for review by the ACRS Subcommittee on March 2, 2016.
