The radiation safety surveillance program (surveys, wipe tests, quality control) is current as of today.



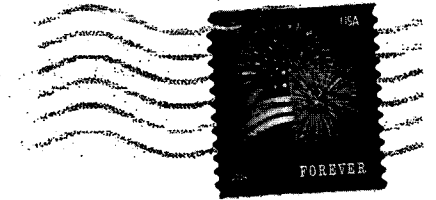
