Hi Mr. Bucci,

I have clarification questions regarding the Army's ICRMP for the installations with sites (Radiation Control Areas) where the Davy Crockett M101 spotting rounds were formerly tested:

For the Army's amendment application, it appears that

1. Pursuant to AR-200-4, the Army has obligations under the NHPA for the use and management of its ranges to include those ranges (sites or RCAs) that contain DU from testing of Davy Crockett M101 spotting rounds. Furthermore, it appears that each installation is required to have an Integrated Cultural Resource Management Plan (ICRMP) that includes all activities at that installation, including the use and management of its ranges.

Army Response: The above statement is essentially true. The requirements of the old Army Regulation (AR) 200-4 were, along with certain other Army environmental regulations, essentially moved into the existing AR 200-1, Environmental Protection and Enhancement [available here: http://www.apd.army.mil/pdffiles/r200_1.pdf], Chapter 6 of which contains detailed requirements to ensure the Army's compliance with the NHPA and other cultural resources statutes and regulations. Paragraph 6-4(a)(1) of AR 200-1 provides that installations will develop ICRMPs as a planning tool. The use of ICRMPs for all DoD components is mandated by Department of Defense Instruction (DoDI) 4715.16, Cultural Resources Management [available here: <http://www.dtic.mil/whs/directives/corres/pdf/471516p.pdf>].

2. Do all the following laws below apply to the Army installations with sites that contain DU from former testing of the Davy Crockett M101 spotting rounds:

Army Response: As a general matter, yes, the statutes and regulations listed above do apply to all Army installations, including those with sites that contain, or are suspected to contain, DU from Davy Crockett spotting rounds.

3. Is the Advisory Council on Historic Preservation (ACHP) and applicable State SHPO concurring parties in the Army's management of historic properties under the NHPA.

Army Response: Yes. The Army fully complies with the NHPA implementing regulations, contained within 36 CFR 800, and consults both ACHP and the relevant state or states' SHPO(s) (as well as any interested tribes) when making decisions on management of cultural resources.

4. If there are any Endangered Species or historic properties (to include Tribal and cultural resources) they would be addressed in each installation's ICRMP?

Army Response: The management of historic properties would certainly be included in each installation's ICRMP. If there would or could be any impacts to threatened and/or endangered (T/E) species, these would be discussed in the NEPA analysis discussing the environmental impacts of the installation ICRMP (such a NEPA analysis for ICRMPs is generally required by 32 CFR 651.33). (Of course, impacts to T/E species from installation activities would also be discussed within the Endangered Species Management Components of the installations' Integrated Natural Resources Management Plans (INRMPs), as well as any relevant Biological Assessments, Evaluations, and/or Opinions, and in consultation with the relevant state natural resources authorities and the U.S. Fish and Wildlife Service and/or National Marine Fisheries Service.)

Please clarify.
