PUBLIC DISCLOSURE FOR BROWNS FERRY NUCLEAR PLANT, UNIT 1  
(CAC NO. MF6760)

Dear Mr. Shea:

By letter dated December 28, 2015 (Agencywide Documents Access and Management System Accession No. ML15363A426), Tennessee Valley Authority submitted an affidavit dated December 8, 2015, executed by Mr. Alan B. Meginnis of AREVA Inc., requesting that the information contained in the following document be withheld from public disclosure pursuant to Title 10 of the *Code of Federal Regulations* (10 CFR) Section 2.390:

ANP-3458P, Revision 0, "AREVA RAI [Request for Additional Information] Responses for Browns Ferry Unit 1 Cycle 12 MCPR [Minimum Critical Power Ratio] Safety Limits," dated December 2015

The affidavit stated that the submitted information should be considered exempt from mandatory public disclosure for the following reasons:

- 6(b) Use of the information by a competitor would permit the competitor to significantly reduce its expenditures, in time or resources, to design, produce, or market a similar product or service.
- 6(d) The information reveals certain distinguishing aspects of a process, methodology, or component, the exclusive use of which provides a competitive advantage for AREVA in product optimization or marketability.
- 6(e) The information is vital to a competitive advantage held by AREVA, would be helpful to competitors to AREVA, and would likely cause substantial harm to the competitive position of AREVA.

We have reviewed your application and the material in accordance with the requirements of 10 CFR 2.390 and, on the basis of the statements in the affidavit, have determined that the submitted information sought to be withheld contains proprietary commercial information and should be withheld from public disclosure.


Therefore, ANP-3458P, Revision 0, marked as proprietary, will be withheld from public disclosure pursuant to 10 CFR 2.390(b)(5) and Section 103(b) of the Atomic Energy Act of 1954, as amended.
