Specifically, the following items were discussed:

1. Letter associated with Title 10 of the *Code of Federal Regulations* (10 CFR) 20.1406 design features to minimize contamination and generation of reactor waste
2. Letter associated with condensate storage tank compliance with 10 CFR 20.1406
3. Letter associated with multiple spurious operations due to a fire
