Enclosed is Amendment No. 02 to your NRC Material License No. 21-32784-01 in accordance with your request. Please note that the major changes made to your license are printed in **bold** font, including the addition of ADAMS accession numbers for all documents in Condition No. 14 of your license.

We also changed Condition No. 14, to correct the identity of your "application dated February 23, 2010" to "letter dated February 24, 2010."

We also deleted Condition No. 13, as it appeared on Amendment No. 01, as it was no longer necessary for expression on your license. Your subsequent Conditions have been renumbered as a result.

Please review the enclosed document carefully and be sure that you understand all conditions. If there are any errors or questions, please notify the U.S. Nuclear Regulatory Commission, Region III office at (630) 829-9887 so that we can provide appropriate corrections and answers.


