Dear Mr. Hanson:

The Region I Field Office, NRC Office of Investigations (OI), initiated an investigation (Case No. 1-2014-022) on July 18, 2014, to determine whether a Senior Reactor Operator (SRO) at R. E. Ginna Nuclear Generating Plant deliberately falsified his work hour records to cover-up a potential violation of NRC work hour rules. Based upon documentary and testimonial evidence developed during the OI investigation, there was insufficient evidence developed for the NRC to substantiate that the SRO deliberately falsified work hour records.

Please note that final NRC investigation documents, such as the OI report described above, may be made available to the public under the Freedom of Information Act (FOIA) subject to redaction of information appropriate under the FOIA. Requests under the FOIA should be made in accordance with 10 CFR 9.23, Requests for Records, a copy of which is enclosed for your information.

Also, in accordance with 10 CFR 2.390 of the NRC's "Rules of Practice," a copy of this letter will be available electronically for public inspection in the NRC Public Document Room or from the Publicly Available Records (PARS) component of NRC's document system (ADAMS).
