

U.S. Nuclear Regulatory Commission Public Meeting Summary

Title: Public Meeting to Discuss Mitigation of Beyond-Design-Basis Events Proposed Rulemaking

Date of Meeting: January 21, 2016

Meeting Identifier: 20151834

Location: One White Flint North - Commission Hearing Room

Type of Meeting: Category 3

Purpose of the Meeting: Discuss with stakeholders the proposed Mitigation of Beyond-Design-Basis Events (MBDBE) rulemaking, issued for public comment on November 13, 2015, (80 FR 70609) and available at www.regulations.gov, Docket ID NRC 2014-0240. The meeting was intended to provide stakeholders with a more comprehensive understanding of the proposed rule and its supporting guidance, so that stakeholders can provide more informed written comments in response to the proposed rule.

General Details: Representatives from the public, licensees, and Nuclear Energy Institute participated in the public meeting in-person, on the phone and via webinar. In total, there were approximately 40 participants in this meeting, about half participating remotely (webinar and monitored bridgeline).

Summary of the Presentation:

Mr. Timothy Reed and Mr. Eric Bowman of the U.S. Nuclear Regulatory Commission (NRC) staff led the meeting using slides that discussed the proposed rule and supporting information. Included in the discussion was the draft regulatory guidance, supporting regulatory analysis/backfit analysis, and specific questions where NRC is requesting feedback on elements of the proposed rule and cumulative effects of regulation. Stakeholders were encouraged to provide written comment following the direction in the *Federal Register* notice. The public comment period for the MBDBE rule closes on February 11, 2016. Staff also highlighted the next steps in the rulemaking process including the consideration of public comments, interactions with the ACRS, construction of the final rule (and guidance documents), and the upcoming public participation in those steps.

Public Participation Themes: The NRC staff interacted with meeting participants regarding questions and areas where stakeholders needed additional clarification on the proposed rule.

Stakeholders were encouraged to submit these comments and questions in response to the published proposed rule so that the NRC can take them under consideration.

Action Items/Next Steps:

- Stakeholders will provide written comments in response to the proposed rule as directed by the *Federal Register* notice.
- NRC will review the written comments provided on the proposed rulemaking and revise the final rule appropriately.
