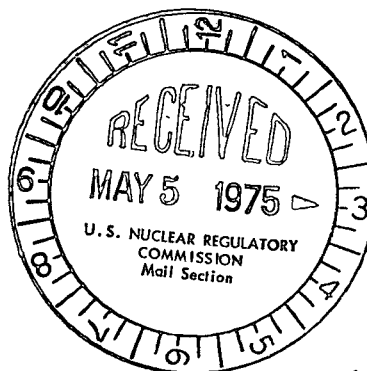

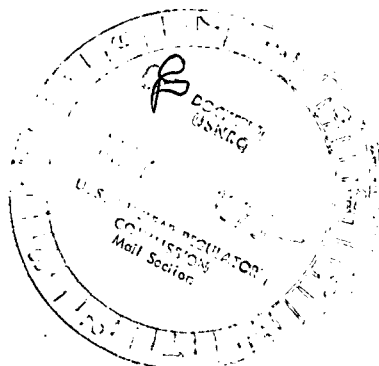

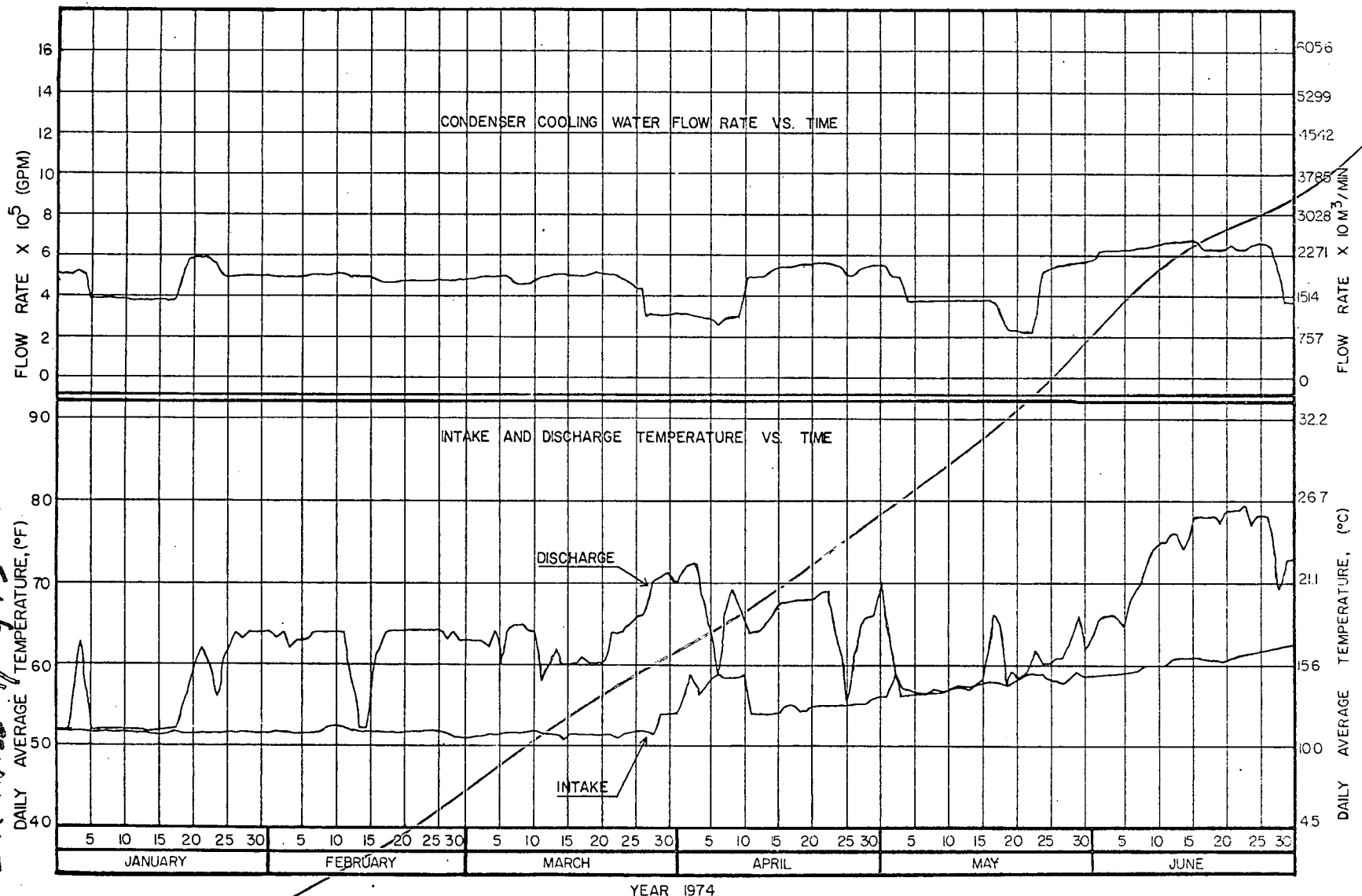


FIGURE 1.1-1
