We are advising Congressman James Mann of this referral by copy of this letter.

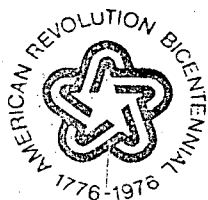

Dear Representative Mann:

This will confirm our telephone conversation of April 15th on "Fuel Adjustment Charges" that have been passed along to unresponsive consumers with the approval and cooperation of the Federal Power Commission.


The meeting of Cooperative Members was held as advised. I really regret that you were unable to attend. The consensus of opinion concerning appellate federal offices and their responsibilities or lack of it would have been most enlightening. You would have been gratified at remarks concerning the conduct of your particular office.

I am sending you a copy of a letter received today from Broad River Electric Cooperative in which they have listed the several docket numbers of formal interventions dating back to 1970. Apparently no hearing has been granted by those who have been petitioned.

The appointed commissioners may have just cause for their actions but they appear most unresponsive, autocratic and dogmatic to the people of this area by denying them the right to petition by negotiation.

Your supporters in South Carolina are hoping that you will improve your excellent position by spear-heading a drive to eliminate this fuel adjustment item that they regard as most unfair and unjustified.

Dear Mr. Staples:

We appreciate your attending the meeting of consumers of Broad River Electric Cooperative Monday night. The several questions and comments from the floor were of great help in shedding light on the true magnitude of the problems that we face.

During the discussion, it was pointed out that certain formal interventions in various rate increases by Duke Power Company had been made by Electric City of North Carolina, Piedmont Municipal Power Systems, North Carolina Electric Membership Cooperation and Saluda River Electric Cooperative dating back to August 19, 1970 and that to date, these interventions had not been settled. The dockets include the following F.P.C. Docket Nos. E-7557; E-7720; E-7988 and A.E.C. Docket Nos. 50-269A; 20-270A; 50-413A and 50-414A; #50-287A. You will note, these are interventions both with the Federal Power Commission (F.P.C.) and the Atomic Energy Commission (A.E.C.).

Recently, Broad River Electric with the other intervenors appointed the firm of Crisp, Belch, Smith and Clifton of Raleigh, North Carolina as our representative and gave them certain authorities to negotiate a settlement of these cases on our behalf. To date, we still have no reply.

Once again, thank you for your interest in Broad River Electric Cooperative. Look forward to seeing you at the annual meeting on May 31, 1975.
