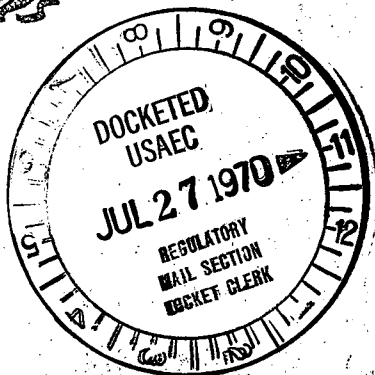
Dear Dr. Morris:
