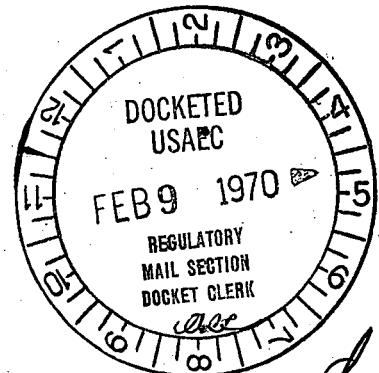
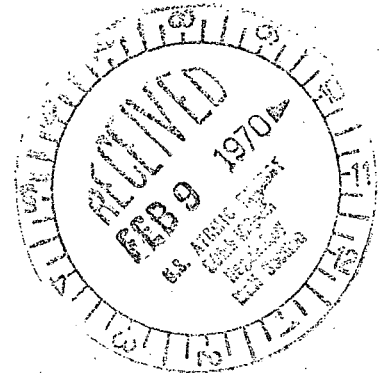


BEFORE ME, this day personally appeared A. C. THIES, Vice President of Duke Power Company, who, first duly sworn, deposes and says:
